

ORDINANCE NO. 1

TENTATIVE
COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE
OF THE ROCHESTER PUBLIC LIBRARY DISTRICT
FOR THE FISCAL YEAR BEGINNING
JULY 1, 2023 AND ENDING JUNE 30, 2024

WHEREAS, the Board of Library Trustees of the ROCHESTER PUBLIC LIBRARY DISTRICT, comprised of parts of Christian and Sangamon Counties, Illinois, has caused to be prepared in tentative form a Combined Annual Budget and Appropriation Ordinance for Fiscal Year 2024 as hereafter set forth.

SECTION ONE: That the following Tentative Combined Annual Budget and Appropriation Ordinance containing an estimate of receipts and expenditures for the fiscal year be, and the same is, hereby prepared as the Tentative Combined Annual Budget and Appropriation Ordinance of the ROCHESTER PUBLIC LIBRARY DISTRICT for the fiscal year beginning July 1, 2023 and ending June 30, 2024:

Security Fund and Special Reserve Fund of the ROCHESTER PUBLIC LIBRARY DISTRICT shall be, and the same are, hereby proposed to be appropriated for the objects and purposes therein specified to pay all necessary expenses and liabilities of the ROCHESTER PUBLIC LIBRARY DISTRICT for the fiscal year beginning July 1, 2023 and ending June 30, 2024.

SECTION THREE: That the invalidity of any portion or item of this Ordinance shall not render invalid any other portion or item thereof which can be given effect with such invalid portion or item eliminated.

SECTION FOUR: That the Board of Library Trustees of the ROCHESTER PUBLIC LIBRARY DISTRICT has by Ordinance No. 86-1 established a Special Reserve Building and Equipment Fund pursuant to the provisions of the Public Library District Act for the accumulation of the unexpended balances of the proceeds received annually from public library taxes, and any such unexpended balances for the fiscal year ending June 30, 2023 may be transferred to the Special Reserve Building and Equipment Fund.

SECTION FIVE: That this Ordinance shall be in full force and effect from and after the date of its passage, by a favorable vote of the Board of Library Trustees, and approval and publication in the manner provided by law.


